- 1. Approval of Agenda—1st Chris; 2nd Kitty

- 4. Coordinator's report and discussion items
 - a. Status report for programs and need to catch up with Perkins fund programs: Coordinator noted that some two-year abridged reports have fallen through the cracks, due to the transition to a six-year assessment schedule and the transition to new coordinator at mid-academic year. Liberal arts programs receiving Perkins funds were sent customized abridged templates in September (due in January). CDFS and Human services were due in Spring—customized templates were just sent. Maire Morinec will be contacted to see if there is any flexibility in the two-year cycle, and verify expected deadlines for each Perkins-funded program.
 - b. Assessment schedule by year rather than by School: A re-arranged schedule would clarify what is expected each academic year to identify more easily those programs that are falling behind.
 - c. Task forces on "general degrees" update: coordinator has not yet determined current status of each task force's efforts. Timely movement of launched program deletion proposals through the curriculum approval process in CurricUNET is uncertain. Coordinator will follow up with articulation officer and other curriculum representatives at the next Curriculum Committee/Tech Review meeting (9/26/17). Coordinator will ask Senate for outreach re: TMC for Elementary Education, and will follow up with VPAA to inquire about contract funds for Elementary Teacher course creation.

Once the AA-T in Elementary Education is created, the college will have to determine what to do with the existing University Studies degree in education. Maureen noted the potential usefulness of a degree/certificate focused on adult education (for example, corporate training, professional development, parenting skills, etc.).

- d. Revisions to template and handbook for 2018-19: Guidelines for the abridged report's contents were in the handbook but there was no approved template. A template was developed to help faculty comply with the requirements. This ad-hoc template should be reviewed by Maire Morinec to determine what aspects are required by the Chancellor's Office and how much flexibility the committee might have to make substantive changes.
