WHEREAS student access to community college initial and continuing enrollment is often unavailable or unattainable due to limited or unavailable financial support for those students most in need and / or desirous of community college enrollment, and

WHEREAS the Solano Community College Academic Senate has initiated a program whereby distinguished faculty are nominated and selected annually as Full Time Distinguished Faculty and as Part Time Distinguished Faculty, and

WHEREAS the Solano Community College Academic Senate has maintained a surplus of operating funds based on faculty — donated Faculty Association dues, therefore

BE IT RESOLVED THAT the Solano Community College Academic Senate wishes to establishes an Academic Senate student scholarship award program in the name of Solano Community College Distinguished Faculty which would award scholarship monies each year to the Solano Community College Scholarship Foundation in the amount of \$500 in recognition of the contributions of our Distinguished Faculty winners.
