#	Initiative / Goal	Description for this Initiative / Goal
1	Design eLumen assessment module	eLumen requires a series of protocols and default settings to be in place before any assessment can occur. This includes adding various scales and rubrics that the faculty will be able to use for assessment.
2	Fix SLOs in eLumen	There are still courses with missing/incomplete/substandard SLOs that need to be addressed once all the courses have been approved in eLumen. This will also continue the previous goal of achieving 100% SLO inputs.
3	eLumen training	This will be a top-down systematic approach. Fall 2019: A.C., deans, and a few others that have requested a more robust access. Spring 2020: begin Faculty training
4	eLumen handbook/training manual	The previous META handbook will all but need to be tossed out and an eLumen one created.

5	Pilot assessments/implementation in eLumen	Fall 2019, the A.C. will perform individual assessments in eLumen in order to test the system. If eLumen is deemed ready, campus-wide assessments will take place Spring 2020. If not, then we will have a couple volunteer programs pilot the system. Full implementation will then begin Fall 2020.
6	Flex events	We will continue holding flex events that will address training and the continued dialogue concerning ILOs and GELOs which began Fall 2018.
7	Newsletter	Continue to produce the A.C. newsletter established under the previous tenure.

Self-Assessment

- To what degree has the committee met its roles and responsibilities?
 I think under the circumstances of transitioning from Meta to eLumen, the committee (all returning members) were very patient and understanding. I would have like to achieve more but getting out default assessments for SP 2020 is a very good thing (regardless of them being optional)
- How can the committee improve its effectiveness in meeting these roles and responsibilities?
 I think I need to be better at delegating responsibility. I really was treading lightly due to the transition but I took on more than I was able to complete.
- How effective was the committee in completing its initiatives?
 Some div coord are far more involved in getting the information out to their people. I honestly do not know how to get them to convey information better but I will just be more forceful.
- How might the committee improve its effectiveness in regard to completing initiatives? Some div coord do need to step up more than they have. I do believe their anger and frustration over the eLumen transition should be over and next year those individuals will hopefully be more engaged.
- How effective was the committee in impacting student success? Not sure this really applies to the AC...but we are attempting to impact our faculty with the new assessment tools. So in a way this would impact our students positively.
- How might the committee improve its effectiveness in regard to impacting student success? N/A
- What resources are needed to assist the committee in meeting its initiatives?
 Nothing I can think of at the moment. eLumen has good customer service and assigned trainers so any issues can get resolved rather quickly.
