#### Self-Assessment

- To what degree has the committee met its roles and responsibilities?  
*Given the budget constraint, I think we accomplished quite a bit. The issues with eLumen have been solved. We are finally implementing the system faculty wide.*
- How can the committee improve its effectiveness in meeting these roles and responsibilities?  
*The committee has done its due diligence: goals such as an updated handbook, more complex trainings, and the mapping will all get completed in time.*
- How effective was the committee in completing its initiatives?  
*We accomplished what we set out to do which is finally implement eLumen.*
- How might the committee improve its effectiveness in regard to completing initiatives?  
*More funding: bring back the school coordinators so the committee membership is secure and there is a direct/consistent line of communication with each division.*
- How effective was the committee in impacting student success?  
*In a very round-about manner, the campus-wide submission of SLO assessments will force faculty to evaluate how their students are doing.*
- How might the committee improve its effectiveness in regard to impacting student success?  
*I think there still needs to more dialogue with faculty to convince them (as a whole) that assessments are more than just an accreditation mandate and a contractual obligation. Assessments, and how faculty utilize them, can help them improve as teachers which will greatly impact their student success.*
- What resources are needed to assist the committee in meeting its initiatives?  
*More funding in terms of release time for the coordinator and bring back the division coordinators.*

#### Recommendations

- Provide recommendations for changing the description or composition of the committee to achieve its initiatives addressed for next year.  
*Without the division coordinators, I will have to do a better job at recruiting faculty from all divisions. We made quorum this semester but I do not believe every division was represented which means I really had no feedback from them other than if individual faculty reached out to me.*

- What topics should be addressed by the committee next year?  
*The handbook definitely needs to be updated. Some faculty are asking for more capabilities so this means more training as we look toward Canvas integration, and the elimination of a default system for a faculty-based one (which is the standard across eLumen-using colleges).*
- Are there additional roles or responsibilities this committee should be addressing?  
*Because the two are technically two sides of the same coin, I would like to see more collaboration with Program Review.*
- What issues, initiatives, or work has the committee identified that other committees, service areas, and/or disciplines or Schools should address next year?  
*Continuing the former question, I do think that the schools coming up for PR need to spend some time looking at their SLOs: do they need to be updated to eliminate "bias" or updated in general? Do they need to be written in the first place (not surprisingly some CORs still have 0 SLOs). The eLumen COR section concerning Outcomes includes course objectives and SLOs and these should always be reviewed and revised as needed as time passes.*
