UCTCA Approvals

UCTCA = UC Transferability

First step in process to transfer courses to UC.

- Next Steps for some/all:
 - IGETC
 - Major/Campus approval

2021 Approvals:

Decisions released October 2021

- 59 courses submitted
 - 57 approved
 - 27 re-review (substantial changes/retained approval)
 - 29 new approvals
 - 2 denied – appeals submitted

Varied Effective Dates

C-ID is required for Transfer Model Curriculum, the foundation of the “ADT” degrees.

Agreed upon articulation between California Community Colleges and *some* CSUs

NOTE: Will become even more important with recent AB 1111 – requiring common numbering system between CCCs

AP Exam Chart

- Updated to align with minimum CSU standards
- Updated to reflect UC units
- Added missing courses required for (at least) unit credit
- To Do:
 - Determine where we still fall short/aren't allotting course credit in a beneficial way
 - Ex: Spanish – does not align with UC Davis

CLEP Exam Chart

- Updated with correct GE Areas and to meet CSU guidelines/ standards
- Added missing courses
- Verified acceptability



2021-2022 In Progress

Ethnic Studies

- CSU Ethnic Studies – GE Area F Requirement
- Students with catalog rights beginning 2021-2022, who are planning to transfer to a CSU, must have this course
- SCC Goal: 5 courses approved for Fall 2022
- Curriculum Deadline: November 18th

CSU/IGETC

- Prepare for CSU and IGETC submissions in early December

C-ID

- Monitor in-progress
- Clean up duplicates
- Analyze in preparation for AB 1111



Pending Projects

ASSIST Clean Up

- UC informed issues with databases due to leading zeros not being present in ASSIST

eLumen Clean Up

- Courses show as pending transferability –have to manually update each course

UC/CSU Major Articulation

- Out of date articulations at many campuses/with many programs

CPL

- Credit for Prior Learning
- Work with CPL Task Force for implementation of process at SCC

Soon...**

AB 1111

- Common numbering system with CCCs
- C-ID Updates – Best guess: will likely be changing course numbers to C-ID
- May require total overhaul

AB 928

- All students indicating transfer placed on ADT pathway unless they opt out
- Establishment of singular lower-division GE pathway for CSU and UC
- Will need to truly ensure students are able to be on a 60-unit pathway (no hidden units, no

Ethnic Studies – CCC and UC

- Requirements for Ethnic Studies for local GE and UC GE are pending and will need to be implemented once guidelines established/approved
- May correlate with AB 928 requirements for UC
