The committee is operating under its new calendar/meeting system: three weeks of drop-in workshops have occurred and tech review follows next week before the first official full committee meeting of the semester.

Guided Pathways – Michael Wyly: "Falcon Day" (Friday, April 24) is being planned: HS outreach, bringing students on to campus to (priority) register with an Ed plan, FAFSA and SCC application already in place.
