## A/S PRESIDENT'S UPDATE

## S/P ESPOSITO-NOY REPORT

Vaccine Mandate: the Board has asked to be presented with options on this. We want to create a mandate that is fair, implementable, and flexible. The Faculty Union is discussing it this week as well, so S/P Esposito-Noy will present a plan to the BoT on Sept 15. The mandate will be a resolution first; policy/procedure will follow. Looking at what this means for mid-semester students that are on campus with no virtual alternative option. Senators then discussed some concerns about disproportionately impacted students and a desire to make sure the mandate message is welcoming, supportive and provides viable options for students. Enrollments are not looking good. We are 11% down on head count as of Friday; FTES is down as well. The trend at neighboring schools is between 18-25% down. Efficiency is up: 484 (goal is 525).

We have formally accepted the Chancellor's Office offer for hiring 7 new faculty for the 2022-23 academic year. One of those positions will need to be earmarked for Ethnic Studies to meet the new CSU graduation requirement. The hiring prioritization process will commence earlier than usual.

#### VPAA REPORT

Reports have been received that start of semester was chaotic for students; the helpdesk was overwhelmed with students unsure of where to go for their online classes, how to access Canvas, and even when asynchronous online classes start. Looking for faculty input on our expectations of students for first day/week online, what do faculty send/say to students (and when) before the first day of class? Discussion on how we can better prepare our students for the start of the semester ensued.

Accreditation process and expectations for report are changing. The ACCJC will conduct a virtual training for SCC on September 17 from 1:00-4:00 to help us begin our next ISER (Institutional Self-Evaluation Report). Anyone interested in participating in our process should attend.

## VPSS REPORT

ASTC has hired all their tutors for the year. Research & Planning is down to one research person temporarily; a Dean of R&P posting will come out soon, and the college is planning to hire another position as well. Counselors are all booked for the next two weeks; if students need to meet with a counselor, they should pursue setting up an appointment now. The college will be hiring an Outreach Specialist (special populations) in September. Guided Pathways had a great mini retreat earlier this month. Still looking for STEM PACE coordinator.
