# A/S PRESIDENT'S UPDATE

- Reminder: Fall 2021 Plenary will take place Nov. 4-6 at Long Beach; Senate President
  Jaimez will not be using our allocated in-person spot, so if anyone would like to attend
  please let her know by 10/1. If you'd like to attend virtually, 10/28 is the deadline to
  register.
- Pres. Jaimez will be meeting with ASSC on 10/5 to discuss a pro-academic integrity campaign and other ways to collaborate.
- Christina Taliaferro will begin as the new Academic Senate Administrative Assistant on October 7th.
- October 15 is the upcoming deadline for Senate's hiring prioritization process; all
  requests are due to office of Academic Affairs on that date.
- The Brown Act Exemption has been extended, allowing meetings to continue virtually while remaining compliant with the Brown Act

## S/P ESPOSITO-NOY REPORT

Introducing and Welcome to Susan Wheet, our new VP of Finance and Administration. Rob Diamond will continue on as volunteer support for a time.

Thank you to Erica Beam for creating a student Canvas course for COVID that students can use to navigate the vaccine/testing mandate. A separate course will be created for faculty and staff. Oversight access to these courses will only be given to HR and COVID caseworkers, to facilitate documentation upload and tracking of the mandate requirements. If students haven't submitted their documentation to the Canvas shell, they'll receive a CourseKey red flag so that COVID caseworkers can stay on top of documentation.

#### Academic Integrity workgroup

Senate would like to initiate a workgroup in addition to a campaign of outreach to students via the ASSC.
