I. CALL TO ORDER

President Johnson called the meeting to order at 12:34pm. Senator Smith took the minutes.

IV. APPROVAL OF AGENDA

V. APPROVAL OF MINUTES (5:00 Minutes)

VI. PUBLIC FORUM

Dr. Dambrosio is coordinator of this year's accreditation effort. She said the report is on the homepage of the website. The Accreditation Commission will be visiting at any time starting next Thursday. They are anticipating a one to two day visit. The commission will investigate the knowledge of students and faculty on the schools accreditation. There will be a potential open session for the commission to ask students questions in an open forum. The school will provide evidence that we are adhering to our school improvement plan. Senator Thomas asked where we can find the accreditation report. Dr. Dambrosio directed that we are able to find it on the mysolano website under the accreditation tab. Dr. Dambrosio said that she encourages asking questions and student involvement, in addition, she commended the student government.

Solano student Terrel, a member of the public attends the ASSC meetings to observe, and see what positions this can lead to.

VII. VICE PRESIDENT'S REPORT

A. Diane White

Not present.

VP White asked for the student government to introduce themselves. She also requested that the group provide items they would like for her to report, being that there are many items to report. She commended that the student forums are a great way to mold policy. VP White asked to entertain questions. VP Castillo asked what her background is. VP White started teaching in the 80's teaching history, with an emphasis in revolutionary history. She was asked to apply to be vice president during a recruitment effort, and was appointed interim VP. Her contract was extended to next year. President Johnson asked what her role is within the school. She states that she is the Vice President of Academic Affairs. She has an important role with overseeing the curriculum and ensuring that the district complies with all education codes. This is known in some districts as Chief Academic Officer or Chief Compliance Officer. She makes recommendations to the school president and governing board. She expressed that her fundamental question to all faculty and administration is "how does your action improve student success". She encourages that students also become proactive, and interface with people in decision making positions. It allows for a streamlined process of problem solving and resolving issues including student and faculty input. Senator Jaramillo said, "you stated you had a vision of what Solano could be, what is that vision". VP White responded with her mission is to focus on what evolves student success. Not just talking about student equity, but being about student equity. She observed that we have a tendency to get trapped in the smaller details instead of looking at the bigger picture. "getting trapped in the weeds". Senator Bess asked "what is your feeling on AB 955". VP White responded with it can be a socioeconomic and access issue. VP White mentioned that she didn't come from the upper strata of the socioeconomic scale. Student Terrel asked what is the meaning of "getting trapped in the weeds", and VP White summed up that it is getting focused on a sentence in a book, rather than the book in its entirety.

Senator Thomas asked, "what is your feeling about the LR10 conversation". VP White answered that this is where her role becomes Chief Academic Officer with compliance in AB 955. She said it is like an automotive student that needs to take a co-requisite in actually working on a car. LR10 relates with student success. In 2009 there was a pilot study from the 2008-2009 LR10 pilots. Our campus researcher gave a report to VP

White and President Laguerre , which stated that LR10 students in conjunction with English 001 were less likely to get an “A” grade. We do not want a co-requisite that alienates student sub-groups. Senator Garcia asked how white students succeeded with LR10. VP White responded that with ethnic groups performing at lower success rate than white students. LR10 caused a negative impact on LR10. There was a lack of oversight. The curriculum is reviewed every six years, career technical education is reviewed every two years. With the pilot program showing two years of discouraging data, LR10 still proceeded. VP White received an email from the Chancellors office that says a two percent increase in student success does not validate student success. There may be a possibility that we may have to give back all the money to former LR10 students. Senator Lewis stated that she saw no equity being an LR10 student. VP Castillo enters 12:53

VIII. INSTRUCTOR'S REPORT

A. Felipe Wilson

Professor Wilson said the final is due this Friday in his mailbox. He went on to discuss that he is pleased with the student government. During his reflections at CCCSA and commends the group for the team work. A professor at the conference presented that he has a student lobbying group that reviews assembly bills that affect students. This student lobbying group travels to Sacramento to speak with Legislators regularly and visit Washington D.C. once a year. Professor Wilson said there may be negative connotations with lobbying groups, but could have a beneficial impact to protect students. Professor Wilson encouraged that the student government looks into big ticket items, for agenda items. There are projects such as leadership trainings or retreats that we can look into doing. The fiscal feasibility will be discussed at a later date.

President Johnson asks to entertain a motion to suspend the orders of the day to go back to Item 7, Vice President Whites Report.
