Action Item: Career Tech moves to suspend the rules and have Dr. Powell go first. Business, Kevin Butt seconds. 11-0-0. Motion passes

- A. Shared governance- Dr. Powell.
  - 1. Hierarchy of the system, ASSC towards the bottom and the foundation of the policy making.
  - 2. Constitutional bylaws cannot be scammed over, they must be looked and read over in detail.
  - 3. The educational code that grants the ASSC authority: 76070.
  - "Shared Governance" doesn't mean shared power goals!
    -encourages appropriate delegation authority.
    -enhances access to governance mechanism
  - What ASSC has a say in -grading policies
    - -codes of student conduct (disciplines)
    - -academic disciplinary policies
    - -curriculum development
    - -additional/deletion of courses or programs

-institutional planning and budget development -standards policies.

- B. Brown Act Dr. Shirley Lewis
  - 1. Importance of the Parliamentary procedure, and how it teaches respect t and allows for business to get done in a timely manner. It offers equality, order and justice.
  - 2. To make a motion one most say, "I move that..." and it must be remembered this always indicates and action not a suggestion.
  - There are multiple types of motions. Privileged motions are ones that adjourn meetings, allow recess, or call for the orders of the day when things get off track. While subsidiary motions are for avoiding a direct vote, amending a motion, limiting or extending debates, tabling or postponing.
  - 4. The main motion and resolution. -recognition, proposal, second, statement, debate, vote, result, implementation.
  - 5. Meetings must be made public, and a meeting is a gathering of the majority. But the Brown Act does not apply to Ad Hoc committees as long as they are composed solely of less than quorum.

-serial meetings are a violation of the Brown Act!

- 6. Agenda posting must be 72 hours in advance, and "special" or urgent meetings can be 24 hours.
- 7. Violating the Brown Act is a misdemeanor.
