The College website was updated with the new materials.

1	Create CurricUNET META Assessment training materials and hold workshops in the use of the system	Flex presentations by Governet and the Assessment Coordinator on the use of META. Coordinators attend school meetings to support faculty in the use of META. Additional meetings are held as warranted.
2	Open-office hours and other individualized trainings meetings to support faculty with META	Hold weekly open office hours and schedule meetings with departments as needed to update SLOs, Success Criteria, and map GELOs/ILOs in META.
3	Keep faculty informed about assessment related information	Create monthly newsletters to update faculty on Assessment news and provide assessment guidance/support.
4	Update the Solano College Assessment website	Upload all new assessment materials online. Create audiovisual materials to assist faculty. Decide which of the old materials should be kept online.
5	Design interface for CurricUNET PLO assessment module	The committee must design and then work with Governet to create the interface of the PLO assessment module
6	Update the adjunct faculty pay form to reflect use of META	Work with J. Leary to update the adjunct faculty pay form to reflect use of META
7	Provide feedback and approval on CurricUNET for faculty making SLO changes.	Read and provide feedback/approval for SLO only changes made in CurricUNET. Attend curriculum committee technical review meetings as needed.
8	Train faculty in PLO assessments	Create training materials and provide workshops/guidance on how to assess PLOs in CurricUNET.
9	Schedule and hold spring flex trainings on GELO and ILO assessments	Choose 1 GELO and 1 ILO as a quality focus discussion for GELOs and ILOs.
10	Work with accreditation team to comply with all assessment related directives and to supply any needed data for self-study report	Meet with accreditation chairs to determine how the assessment committee can support accreditation self-study team. When deficits are noted, work with the coordinators and committee to find solutions.
11	Assessment Training for Committee Members	Find appropriate training opportunities and funding for committee members to increase assessment knowledge
