

2016–2017 Verification Worksheet Dependent Student

Your 2016–2017 Free Application for Federal Student Aid (FAFSA)/California Dream Application was selected for review in a process called verification. The law says that before awarding Federal Student Aid, we may ask you to confirm the information you and your parents reported on your FAFSA/California Dream Application. To verify that you provided correct information the financial aid administrator at your school will compare your FAFSA/California Dream Application with the information on this worksheet and with any other required documents. If there are differences, your FAFSA/California Dream Application information may need to be corrected. You and at least one parent must complete and sign this worksheet, attach any required documents, and submit the form and other required documents to the financial aid administrator at your school. Your school may ask for additional information. If you have questions about verification, contact your financial aid administrator as soon as possible so that your financial aid will not be delayed.

 <u>TAX RETURN FILERS</u>—Important Note: If the student filed, or will file, an <u>amended</u> 2015 IRS tax return, the student must contact the financial aid administrator before completing this section.

Instructions: Complete this section if the student, <u>filed or will file</u> a 2015 income tax return with the IRS. *The best way to* verify income is by using the IRS Data Retrieval Tool that is part of FAFSA on the Web. If the student has not already used the tool, go to <u>FAFSA.gov</u>, log in to the student's FAFSA record, select "Make FAFSA Corrections," and navigate to the Financial Information section of the form. It takes up to 2-3 weeks for IRS income information to be available for electronic IRS tax return filers, and up to 8-11 weeks for paper IRS tax return filers.

 - 1. <u>TAX RETURN FILERS</u>—Important Note: If the student's parent(s), filed or will file, an <u>amended</u> 2015 IRS tax return the student's financial aid administrator must be contacted before completing this section.

Instructions: Complete this section if the student's parent(s) <u>filed or will file</u> a 2015 income tax return with the IRS. *The best* way to verify income is by using the IRS Data Retrieval Tool that is part of FAFSA on the Web. If the parents are married, and separate 2015 tax returns were filed, 2015 IRS tax return transcripts must be submitted for each parent.
