

SUMMARY:

In order to support the necessary reduction in the College budget, the Board of Trustees and the Superintendent-President have agreed to the following reduction in compensation for the fiscal year 2011-12.

The Superintendent-President will take eight (8) furlough days, forego the 1% salary increase that would have taken effect on June 30, 2011, and suspend the fundraising/entertainment allowance for the 2011-12 fiscal year.



COMPENSATION REDUCTION AGREEMENT
BETWEEN
GOVERNING BOARD
AND
SUPERINTENDENT/PRESIDENT**

In order to support the necessary reduction in the college budget, the Board of Trustees and the Superintendent/President of Solano Community College have agreed to the following reduction in compensation for the fiscal year 2011-2012:

Furlough: Dr. Laguerre will take eight (8) days of furlough for which he will not work nor will he get paid during the 2011-2012 fiscal year.

Salary Increase: Dr. Laguerre will forego a 1% salary increase that would have taken effect on June 30, 2011.

Fund-Raising/Entertainment Allowance: The fund-raising and entertainment allowance is suspended for the 2011-2012 fiscal year.
