(b) <u>Academic Senate</u>

Michael Wyly reported that the Senate has met three times since the last report. On October 30th, the Senate took action to approve the Student Success and Equity Integrated Plan. Professor Wyly thanked Dean Dwayne Hunt for taking the time to meet with the Senate to review the plan.
