VII. INFORMATION ITEMS

- A. Clubs and Campus Funding Discussion
 - a. Department of Art
 - i. We were told that the cost of the Art Department's trip should be covered by some organization within the school.
 - ii. Diana will be contacting them to help direct their discussion
 - b. Pre-Med Club
 - i. Initially requested \$221.30; however, they are requesting \$78.32

- Discussed that the club has been active around campus, has had success with previous Blood Drives, regularly attends/participates in events around the campus, and has a great documented record.
- iii. After deliberation, the ASSC decided to give the club \$85.00
- c. Muslim Student Association Club
 - i. Requested \$2000 for their upcoming Eid Al-Fitr event
 - ii. Discussed that we ASSC's snow cone machine is still being repaired by the Welding Department and cannot be lent to the MSA, the different costs associated with the event, the club's sizeable success when hosting the event during the previous year, the observable impact it has on the general student population, and the level of preparation demonstrated for this event.
 - iii. After deliberation, the ASSC decided to give the club \$2,000.
- d. Drama Club
 - i. Requesting \$1,928.55 with a minimum of \$1,128.00 for a club trip.
 - ii. Discussed the fact that the ASSC is not supposed to pay for advisor conferences, the trip will support a sizeable department/demographic of the college community, their level of activity around the campus, how the trip is paid for including the cost of emergencies.
 - iii. After deliberation, the ASSC decided to give the club \$1,730.
- e. Blue Gene Algae Club
 - i. Requesting \$12,000 for a bioreactor. Discussion is listed below:
 - ii. It was noted that this was a very impressive and noble effort, came to the consensus that the amount was too large for us to pay in full.
 - iii. Discussed that they are a brand-new club that started off in a Solano classroom
 - iv. Their group has won \$8,000 at a college competition that went to the group that was a part of the competition
 - v. They currently have membership that includes the group that competed along with others; however, the club has not provided a comprehensive list of their members.
 - vi. They were anticipating an upcoming Colorado fieldtrip
 - vii. They mentioned that they will need even more money to have a Solano representative to supervise the reactor once it is established
 - viii. ASSC members proposed further discussions with the club to explore transitioning this endeavor into a more academic pursuit than solely extracurricular one
 - ix. The idea is being considered as an ongoing item that ASSC can discuss and support
 - x. The Senate largely agrees that, based on the club's proposal, supporting the club to point where they can be built up to request funding from others/establish themselves
 - xi. Concerns were stated about the long-term planning/sustaining of this effort, the recent establishment of the club, and if it would benefit students beyond the club/group.
 - xii. The Senate agrees that verifiable, documented experience, and

activity will be needed as a reference before further pursuing this request.

- xiii. After deliberation, the ASSC decided to table the Blue Gene Algae Club amount to another meeting pending further discussion.
