- i. Faculty will soon have access to their individual student success data via a portal, thanks to Com St. Germain and Research & Planning's efforts.
- ii. Student Drop Survey will soon be implemented to gather more data on why students don't complete classes and allow SCC to reach out to students who need support. Also thanks to Com St. Germain and Research & Planning's efforts.
- iii. "Promoting a Safe and Secure Campus Community for All Students" statement/policy
  - Meetings held shortly after 2024 election between members of SESC, Superintendent President, VP Student Services, Dean of Student Equity, and Senate President forwarded issues around immigrant-student safety and support.
  - 2. Feb 2025, student leaders organized to urge Board to approve supportive policies for immigrant students and declare SCC "sanctuary" campus.
  - 3. ASSC may be interested in pursuing further college efforts to care/support immigrant students this school year. Possible SESC collaboration on such efforts.
    - a. Example: Revisiting "sanctuary" campus designation (Board did not approve.)
    - b. Dream Center—a physical center of support and protection.
    - c. Know Your Rights and Legal Observer trainings
- iv. Shared Antiracism and DEI Statements. Submitted to VP Williams last school year and were moving through shared-governance approvals process. Need to check on status of this and explore publicizing these statements further. Currently only publicly available on SESC website subpage?
- d. Ideas and interest for future SESC work
  - i. Creating community for students.
    - 1. Importance of clubs. Example: D&D club emerging.
      - a. Title 5 restrictions on who can serve as club advisors. Co-advising between faculty and another employee a good "workaround."
    - 2. Create local exhibit(s) focusing on Solano County people of color. Other ways to show our college cares about local community, local healing of racial injustice.
    - 3. Centralized cultural-event planning
  - ii. Build bridges between faculty and ASC. Supporting adjunct faculty in accommodating students, given their limited paid time.
  - iii. Advocating to lower course-materials costs. Collaborate with ZTC/Materials Cost (combined) Task Force?
  - iv. Ethnic Studies learning/training for SCC employees. PD or Flex workshops/presentations.
  - v. Focus on expecting parents and parenting students.
