

Solano Community College District Code of Conduct

Introduction

To allow community members to use Solano Community College (SCC) facilities and programs in a safe, pleasant environment, conducive to student life, student success, and academic enrichment, this code of conduct has been adopted.

SCC students will adhere to the Standards of Student Conduct policy (Board Policy 5300) when using campus facilities and programs.

Community Member Code of Conduct

When a community member enters a Solano Community College District campus or location, the District assumes that each person will always respect the facility and the rights of all other individuals.

Under California Penal Code §626.6(a), the chief administrative officer of a college, or the officer's designee, is able to request that an unauthorized person immediately leave the campus grounds and refrain from returning for at least seven (7) days. Violations of such a request are a misdemeanor offense punishable by a fine up to five hundred dollars (\$500), six-months imprisonment in the county jail, or both. Further, if the person has a previous conviction for violation of the same statute or other Penal Code statutes regarding crimes on school grounds, the penalties may be more severe (CA Penal Code §626.6 and §626.7).

The following conduct shall constitute cause for community members being prohibited from using SCC facilities.

1.	Community members shall respect the rights of all other individuals and staff members, including their performance of duties.
2.	While on campus, children must be under the direct control of an adult for their safety and security and the safety of others. Campus Security will be called if children are perceived to be unsupervised or unsafe.
3.	Community members shall not engage in disruptive behavior, willful disobedience, habitual use of profanity or vulgarity, or the open and persistent defiance of the authority of, or persistent abuse of, college personnel.
4.	Community members shall not engage in harassing or discriminatory behavior or language based on ancestry, age, disability, gender, gender identity, gender expression, nationality, race or ethnicity, religion, sexual orientation, or any other status protected by law.

5.	Community members shall not engage in intimidating conduct or bullying against another person through words or actions, including direct physical contact; verbal assaults, such as teasing or name-calling; social isolation or manipulation; & cyberbullying.
6.	Community members shall not engage in willful misconduct that results in injury or death to an individual or which result in cutting, defacing, or other injury to any real or personal property owned by the district or on campus.
7.	Community members shall not commit sexual harassment as defined by law or by district policies and procedures.
8.	Community members shall not unlawfully possess, use, sell, offer to sell, or furnish, or be under the influence of, any controlled substance listed in California Health and Safety Code Sections 11053 et seq., an alcoholic beverage, or an intoxicant of any kind; or unlawful possession of, or offering, arranging or negotiating the sale of any drug paraphernalia, as defined in California Health and Safety Code Section 11014.5.
9.	Community members shall not steal or attempt to steal district property or private property on campus, or knowingly receive stolen district property or private property on campus
10.	Community members shall not cause or attempt to cause damage to district property or to private property on campus.
11.	Community members shall not possess, sell or otherwise furnish any firearm, knife, explosive or another dangerous object, including, but not limited to any facsimile firearm, knife, or explosive, unless, in the case of possession of any object of this type, the person has obtained written permission to possess the item from a district employee, which is concurred by the Chief of DPS or the Superintendent/President. SCC is in the Gun Free Zone Act – 626.9 Penal Code.
12.	<p>Computer resources exist for academic, research, professional enrichment, and administrative use. Community members are allowed to use District computers, but they shall not misuse or use without authority, the College’s information technology or telecommunications systems. This includes but is not limited to:</p> <ul style="list-style-type: none"> • The unauthorized or illegal use or misuse of college phone and computer network systems. • Unauthorized entry or dissemination of electronic information. • Prank or harassing phone calls or email messages.

	<ul style="list-style-type: none"> • Hacking, duplication, or unauthorized use of copyrighted software; destruction, unauthorized transfer or alteration of electronic files. • Unauthorized use of another individual's electronic identification number, such as password, Social Security number, or PIN.
13.	The copyright law of the United States (Title 17 U. S. Code) governs the making use of copyrighted material. Community members are responsible for any infringement of this law.
14.	The College is not responsible for any personal property brought onto the premises. Community members are responsible for their property and should not leave personal items unattended.
15.	Community members shall not violate any published College regulations or federal, state, or local laws.

Individuals interested in exercising their rights of free expression can do so pursuant to the policies and procedures adopted by the District.
