# 10. REPORTS (NO ACTION REQUIRED)

## (a) Associated Students of Solano College (ASSC)

Board Senator Sriya Srinivasan provided the following ASSC report:

On behalf of ASSC, I'd like to update you all on our election process. Today we had our Mandatory Candidates Assembly meeting in which the candidates discussed ASSC's Election Code. Campaign week will start on April 25th and end on May 5th right before Voting week which will start on May 8th and end on May 11th. Ballots will be collected online.

Other than the election, ASSC has been working on other items such as approving a new meditation room in the library building for student use and planning new events for example a possible cultural day in collaboration with both Solano College's and Early College's cultural clubs. Speaking of events, this coming Saturday, April 22nd, the Muslim Association Club will be holding its Eid festival from 11:00 am - 5:30 pm. It's open to all students, staff, and faculty with an RSVP.

Moreover, ASSC has been in contact with Solano's IT committee to submit input on the new system that will be replaced MySolano hopefully in the upcoming Fall Semester.

### (b) Academic Senate

Academic Senate President Joshua Scott provided the following report:

I will be attending ASCCC Plenary tomorrow with Rebecca LaCount (VP of Academic Senate) and John Perez (DE Coordinator). Below is an excerpt of a welcome statement written by Ginni May, ASCCC President.

"The theme this spring, "Making Space for Connection and Belonging as We Center Authentic Voices and Lived Experiences in the 10+1" is building from the theme last fall. As faculty are engaged with many task forces and work groups, busily implementing recent legislation and making improvements to educational and student support opportunities, everyone must work to make space for connection and belonging. All voices must be heard. The people behind those voices, especially the faculty and students that have been traditionally underrepresented, need to be welcomed into the circle to share their experiences and tell their stories. Hopefully, this plenary session will provide such opportunities."

On April 3<sup>rd</sup>, we heard from Minority Coalition President Shanan Danley. Minority Coalition has been a presence on campus since the 1970s and is represented by staff, faculty, and students.

Monday we'll be hearing from Lauren Taylor-Hill and Matthew Schweitzer, advisors to the LGBTQ club.

We met at the Vallejo Center at the end of March. We are hoping to see more robust class offerings as well as tutoring and counseling.

We also have a scheduling taskforce made up of faculty and administration which is focused on developing a student-centered schedule at each campus (Fairfield, Vacaville, and Vallejo).

# (c) <u>College Governance Council</u>

On behalf of Dr. Esposito-Noy, VP David Williams provide the following CGC updates:

At the March 22<sup>nd</sup> meeting, we provided an update on the Quad Survey. We have received more than 1,000 responses and will provide a summary of the survey at the next CGC meeting. Additionally, VP Wheet discussed the budget timeline, and VP Williams provided updates on accreditation, the CA Virtual Campus, and the new faculty portal developed. VP Neeley advised of the marketing surveys that will be conducted by Interact. The next meeting with be April 26<sup>th</sup>.

# (d) <u>Superintendent-President</u>

On behalf of Superintendent-President Celia Esposito-Noy, VP David Williams provided the following S-P report:

VP Lucky Lofton and the S-P are currently working on the most effective way to provide the Governing Board with timely Measure Q updates. We may resume providing presentations and photos as we did in past years. They are working on this and will have recommendations by the next meeting.

SCC was the location for two successful community events last week: The annual Workforce Development Board's Solano County Job Fair and the Solano County Wildfire Safety

Expo. This coming Saturday, the campus will host Eid Al-Fitr for those celebrating the end of Ramadan. Many thanks to student trustee Ragab for her leadership.

SCC has a list of events in recognition of next week's Black Student Success Week. Dr. Frank Harris will host a virtual session on race lighting on Wednesday at 1;30PM.

In addition to the success of our athletic teams, our Speech and Debate Team is the **2023 Phi Rho Pi Community College National Champions!** The Phi Rho Pi national championship tournament was held from April 10<sup>th</sup> - 15<sup>th</sup> in Washington D.C. where more than sixty of the top community colleges from every region of the country competed. Our Solano Falcons won **Gold Overall Sweepstakes**, **Gold Debate Sweepstakes**, and **Gold Individual Sweepstakes**, in the Hindman small school division. On May 3<sup>rd</sup>, we will welcome our Speech and Debate Team for a small reception and then recognize them at the start of the meeting.

Lastly, the S-P is currently traveling with Professors LaNae Jaimez and Michael Wyly and two of our Phi Theta Kappa students who will accept awards at the national PTK conference later this week.
