WORKPLACE VIOLENCE PLAN

POLICY: The Governing Board is committed to providing a District work and learning environment that is free of violence and the threat of violence. The Governing Board's priority is the effective handling of critical workplace violence incidents, including those dealing with actual or potential violence.

The Superintendent/President or <u>his/her their</u> designee shall establish administrative procedures that assure that employees are informed regarding what actions will be considered violent acts, and requiring any employee who is the victim of any violent conduct in the workplace, or is a witness to violent conduct to report the incident, and that employees are informed that there will be no retaliation for such reporting.

SAFETY

- **POLICY:** The Superintendent/President or <u>his/her their</u> designee shall establish administrative procedures to ensure the safety of employees and students on District sites, including the following:
 - Compliance with the United States Department of Transportation regulations implementing the Federal Omnibus Transportation Employee Testing Act of 1991. Specifically, the District shall comply with the regulations of the Federal Highway Administration (FHWA) and, if applicable, the Federal Transit Administration (FTA). Compliance with these policies and procedures may be a condition of employment.
 - Establishment of an Injury and Illness Prevention Program in compliance with applicable OSHA regulations and State law. These procedures shall promote an active and aggressive program to reduce and/or control safety and health risks.
 - Establishment of a Hazardous Material Communications Program, which shall include review of all chemicals or materials received by the District for hazardous properties, instruction for employees and students on the safe handling of such materials, and proper disposal methods for hazardous materials.
 - Prohibition of the use of <u>all</u> tobacco <u>products</u> <u>district wide, as referenced in Board Policy</u> <u>4215 in all public buildings and not within</u> <u>20 feet of the entrance to any building</u>.

Students, faculty, and staff who may be victims of sexual and other assaults shall be treated with dignity and provided comprehensive assistance. The Superintendent/President or his/her their designee shall establish administrative procedures that ensure that students, faculty, and staff who are victims of sexual and other assaults receive appropriate information and treatment. The procedures for sexual assaults shall meet the criteria contained in EC 67385 and 34 C.F.R. § 668.46.

1. Definitions

"**Customer Data**" means all data (including Personal Data and User data) that is provided to LAERDAL by, or on behalf of, Customer or through Customer's use of the Laerdal Scenario Cloud Platform, and any data that third parties submit to Customer through the Laerdal Scenario Cloud Platform.

"**Data Protection Legislation**" means all applicable laws relating to the protection of personal data and/or the privacy of natural persons, including (without limitation) the General Data Protection Regulation EU 679/2016 ("GDPR") and national legislation which supplements the GDPR.

2. Agreement

In consideration of payment by Customer of the agreed price for subscriptions for Users to Product 215-01050B Laerdal Scenario Cloud in accordance with this Agreement, LAERDAL grants the license specified in Clause 3.2 on the basis of this Agreement.

3. Subscription licenses and Laerdal Scenario Cloud Platform accounts

3.1 Placing an order for a subscription license tier

Customer's and Users' use of the Laerdal Scenario Cloud Platform will require Customer to obtain, or be provided with, an administrative account, including setting up a username and password. Customer is solely responsible for maintaining the confidentiality of Customer account information, including passwords, and for all activity that occurs under Customer's account. Customer agrees to notify LAERDAL immediately of any unauthorized access or use of its account or password. Customer may not use the account, username or password of any other customer at any time.

3.2 Grant and duration of licenses. Upon Customer's acceptance of the Agreement as described in Clause 2 above, LAERDAL grants to Customer the non-exclusive, non-transferable User subscription licenses according to the subscription license tier classification listed in the Quote to enable the Customer's individual Users to access and use the Laerdal Scenarios through the Laerdal Scenario Cloud Platform during the subscription term. The initial subscription term of each subscription license shall be for a minimum of twelve (12) months from the date of the purchase of the relevant subscription license tier. The subscription licenses will automatically renew at the end of each subscription term for additional periods of 12 months unless either party gives the other written notice of non-renewal at least 30 days before the end of the then-current subscription term.

In no event shall LAERDAL or the Third Party Content providers be liable for any delays, inaccuracies, errors or omissions in any Third Party Content, or for any damages arising from the use of Third Party Content.

7. Customer Data

7.1 Customer Data Ownership and Warranty.

LAERDAL and Customer acknowledge that all Customer Data entered into the Laerdal Scenario Cloud Platform by the Customer and its Users is and shall remain the property of Customer and nothing in this Agreement shall restrict Customer's use of its Customer Data. Subject to the provisions of Clause 7.2, Customer Data shall be considered Confidential Information subject to this Agreement. Customer represents and warrants that (a) it has the authority and right to transmit Customer Data through the Laerdal Scenario Cloud Platform to LAERDAL and to grant the license under Clause 7.2; and (b) the use of Customer Data will not infringe the intellectual property rights, other proprietary rights or data protection rights of any third party.

7.2 License to LAERDAL to use Customer Data for Analytics.

Customer grants LAERDAL a non-exclusive, worldwide, perpetual, irrevocable, royalty-free, sub-licensable right to analyze the Customer Data solely for the purposes of improving or enhancing the future functionality and features of the Laerdal Scenario Cloud Platform and for the commercial administration of this Agreement. 8. Confidentiality.

Each Party agrees to secure and protect the Confidential Information of the other in a manner consistent with the maintenance of the other party's rights therein, using at least as great a degree of care as it uses to maintain the confidentiality of its own confidential information of a similar nature, but in no event using less than reasonable efforts. "Confidential Information" means information that a disclosing party considers to be confidential, including but not limited to Customer Data, business and technical information, marketing plans, research, designs, plans, methods, techniques, processes and know-how, whether tangible or intangible and whether or not stored, compiled or memorialized physically, electronically, graphically or in writing. Confidential Information shall not include information which: (i) is, or as of the time of its disclosure or thereafter, becomes part of the public domain through a source other than the receiving party; (ii) was rightfully known to the receiving party as of the time of its disclosure; (iii) is independently developed by the receiving party; (iv) is subsequently learned from a third party not under a confidentiality obligation to the disclosing party; or (v) is required to be disclosed pursuant to an obligation under applicable laws, or a duly authorized subpoena, court order, or government authority request, whereupon the party subject to same shall (except where prohibited by law from doing so) provide prompt written notice to the other party prior to such disclosure, so that such party may seek a protective order or other appropriate remedy. The parties acknowledge that any quotes and pricing shall be treated as Confidential Information

9. Data Protection and Privacy

9.1 Customer privacy.

As an independent data controller, LAERDAL (i) collects and processes contact details of the authorized representatives of the Customer in order to process and deliver the subscription licenses to and manage payment from the Customer under the Agreement, (ii) generates account credentials (username and password) for each customer and individual User; and (iii) analyzes Customer Data for the purposes described in clause 7.2 above. For more information on how LAERDAL handles this information, please visit https://laerdal.com/distributors/support/customer-service/privacy-policy/. This does not apply to Customer Data which is processed on behalf of the Customer in accordance with the provisions of this Agreement.

9.2 Instructions.

With the exception of the processing outlined in clause 7 above, Customer instructs LAERDAL to process any personal data comprised in the Customer Data ("Customer Personal Data") as necessary to provide the Laerdal Scenario Cloud Platform pursuant to this Agreement for the duration of subscription term. Customer is solely responsible for determining the suitability of the Laerdal Scenarios and the Laerdal Scenario Cloud Platform for the Customer's needs and for complying with the Data Protection Legislation in relation to the Customer Personal Data and the Customer's use of the Laerdal Scenarios and/or the Laerdal Scenario Cloud Platform, except for any obligations under Data protection legislation that apply expressly to LAERDAL in the context of its provision of the Laerdal Scenario Cloud Platform. LAERDAL will process Customer Data. Customer Personal Data is determined and controlled by the Customer and includes Personal Data relating to Users of the Laerdal Scenarios and the Laerdal Scenarios and the Laerdal Scenario Response and the Laerdal Scenario Cloud Platform.

9.3 Security.

LAERDAL has, considering the state of the art, cost of implementation, the nature, scope, context and purposes of the Laerdal Scenario Cloud Platform, and the level of risk, implemented appropriate technical and organizational measures to enable a level of security appropriate to the risk of unauthorized or unlawful processing, accidental loss of and/or damage to Customer Data. At reasonable intervals, LAERDAL tests and evaluates the effectiveness of these technical and organizational measures for enabling the security of the processing.

9.4 Data Protection.

Where LAERDAL is processing Personal Data for Customer located in the European Economic Area, LAERDAL will:

(a) only do so on Customer's documented instructions (as set out in Clause 9.2) and in accordance with applicable law, including with regard to transfers of personal data to a third country or an international organization, and Customer agrees that the Agreement constitutes such documented instructions from Customer to LAERDAL to process Customer Data;

(b) To the extent necessary for the provision of the Laerdal Scenario Cloud Platform, transfer Customer Personal Data outside of the European Economic Area, including to Sub-processors (as defined below), provided measures are in place to ensure that each transfer complies with Data Protection Legislation. Wherever possible, LAERDAL relies upon standard contractual clauses for data transfers to countries outside the European Economic Area that do not have adequate levels of data protection as determined by the European Commission;

(c) ensure that all LAERDAL personnel involved in the processing of Personal Data are party to confidentiality obligations in respect of the Personal Data;

(d) make available information necessary to demonstrate LAERDAL's compliance with obligations under Data Protection Legislation where such information is held by LAERDAL and is not otherwise available to Customer through Customer's account and User areas or on LAERDAL websites, provided that Customer provides LAERDAL with at least 14 days' written notice of such an information request;

(e) cooperate as reasonably requested by Customer to enable Customer to comply with any exercise of rights by a data subject under the Data Protection Legislation in respect of Personal Data processed by LAERDAL in providing the Laerdal Scenario Cloud Platform;

(f) promptly notify Customer of all requests received directly from a data subject of any of their Personal Data in respect of that data subject's Personal Data submitted through the Laerdal Scenario Cloud Platform;

(g) cooperate with data protection authorities or privacy regulators in the performance of such regulator's tasks where required;

(h) upon termination or expiry of the subscription term, except where Customer's subscription term is renewed for a further term, delete (or otherwise return to Customer, on Customer's request) the Customer Personal Data, except where prolonged retention is required for compliance with applicable laws; and

(i) assist Customer as reasonably required when Customer is required under the Data Protection Legislation to conduct a Data Protection Impact Assessment in relation to the Laerdal Scenario Cloud Platform.

9.5 Sub-processing.

9.6 Sub-processor List.

LAERDAL will, subject to any confidentiality provisions under this Agreement or otherwise imposed by LAERDAL:

(j) make available to Customer a list of the LAERDAL Sub-processors who are involved in processing or sub-processing Personal Data in connection with the provision of the Laerdal Scenario Cloud Platform, together with a description of the nature of Laerdal Scenario Cloud Platform provided by each Sub-processor ("Sub-processor List"). A copy of this Sub-processor List may be requested here privacy@laerdal.com;

(k) ensure that all Sub-processors on the Sub-processor List are bound by contractual terms that are in all material respects no less onerous than those contained in this Agreement; and

(I) be liable for the acts and omissions of its Sub-processors to the same extent LAERDAL would be liable if performing the Laerdal Scenario Cloud Platform of each of those Sub-processors directly under this Agreement;

9.7 New / Replacement Sub-processors.

LAERDAL will provide Customer with written notice of the addition of any new Sub-processor or replacement of an existing Sub-processor at any time during the term of the Agreement ("New Sub-processor Notice"), provided that Customer signs up to a mailing list made available by LAERDAL through which such notices will be delivered by e-mail. If Customer has a reasonable basis to object to LAERDAL's use of a new or replacement Sub-processor, Customer will notify LAERDAL promptly in writing and in any event within 30 days after receipt of a New Sub-processor Notice. In the event of such reasonable objection, either Customer or LAERDAL may terminate the portion of the Agreement relating to the Laerdal Scenario Cloud Platform that cannot be reasonably provided without the objected-to new Sub-processor (which may involve termination of the entire Agreement) with immediate effect by providing written notice to the other party.

9.8 Security Incident.

If LAERDAL becomes aware of any unauthorized or unlawful access to, or acquisition, alteration, use, disclosure, or destruction of, Customer Personal Data ("Security Incident"), LAERDAL will promptly, and in any event, as soon as reasonably practicable, notify Customer without undue delay. 9.9 Audit.

In the event this Agreement is terminated, Clauses 3-13 and any payment obligations incurred by Customer prior to the effective date of termination shall survive.

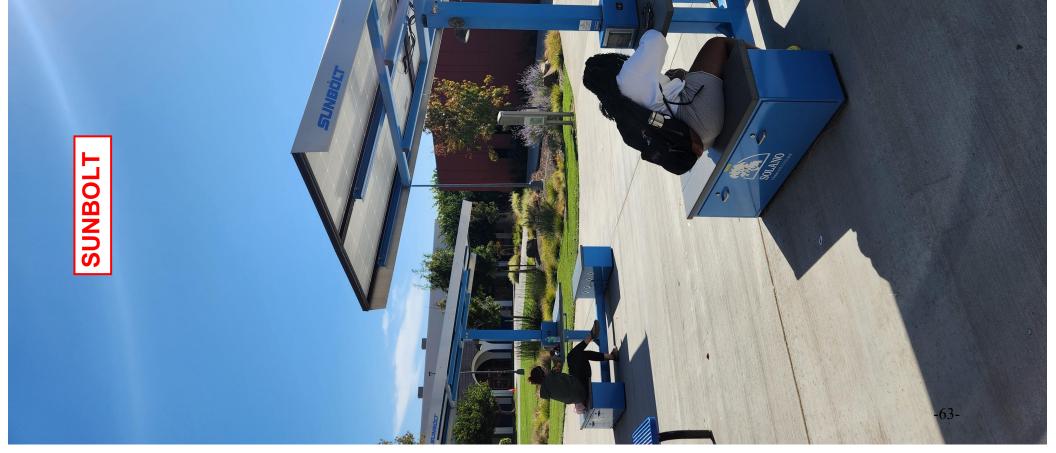

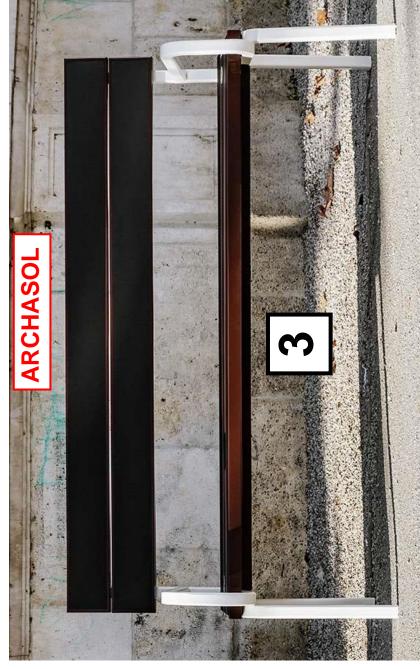

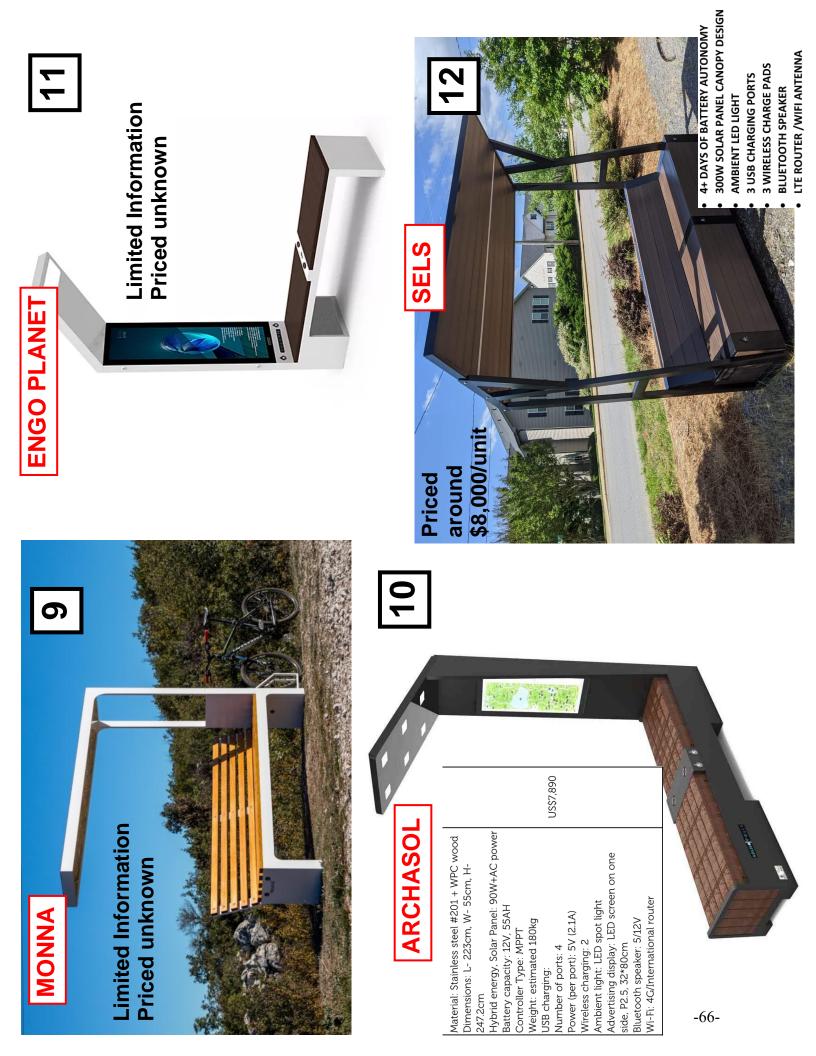
